



AFFIDAVIT

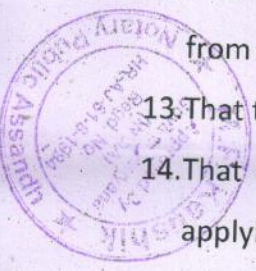
