

DEED OF TRUST

AND WHEREAS the executive committee in it meeting dated 08.09.2007 has decided to appoint two new trustees as mentioned in part One. In pursuance of the same the CONTINUING TRUSTEES propose to appoint NEW TRUSTEES as trustees of the trust.

AND WHEREAS it is desired by the parties to appoint the new trustees by a deed and to transfer the properties and assets of the trust to the new trustees alongwith the continuing trustees so as to vest the same in them.

NOW this deed witnesseth as under

- 1. That the continuing trustees in exercise of the powers conferred on them by the said trust deed appoint NEW TRUSTEES of the said trust for all purposes to act jointly with the CONTINUING TRUSTEES in the said trust and declare that the continuing trustees do hereby grant, convey and transfer all the properties and assets to have and hold the same unto the new trustee alone and jointly with the continuing trustees to the use and upon the said trust and with the same powers, provisions and obligations as are specified in the said trust deed to the intent and purposes and as if the new trustee was originally appointed as trustee by the said deed of trust.
- 2. That the executive committee as per clause 16 shail stand amended as hereunder

- 3. That clause 13 B shall be substituted with the new clause as under "That the chairman of the Trust shall be elected/ nominated from the trustees by majority vote"
- 4. That clause 13D shall be shall be substituted with new clause as under "That all the investment of the trust shall be made by the chairman as decided in the meeting of the Trustees."

5. That pursuant to amendment in clause 13B as stated above, the phrase in clause Mohe RPhoral Manjeet Summin Singh

"The Chairman shall not be liable to retire, but shall continue to be the chairman of the trustees during his life time" shall stand deleted.

6. That the Clause 26G shall be substituted with new clause as under "To decide all questions arising in the administration of trust hereof and including all question relating to the interpretation of these presents or otherwise concerning or touching these presents or any clause or thing herein contained or touching or concerning anything or matter relating to connected with or arising out of these presents and interpretation or the operation thereof "
